Enclosed please find several Amended Reports of Receipts and Disbursements as well as the Year End (2014) Report of Receipts and Disbursements for the Chris Dahlberg for U.S. Senate Committee (C00550458). Each Amended Report is explained below.

Amended 4th Quarter Year End (2013) Report

The Paypal fees on the original report were understated by \$25. The change has been made and new amount is reflected on Schedule B (page 47) which is included herein.

Amended 1st Quarter 2014 Report

Arlo Peterson cash donation was understated by \$5. Also, there was a Paypal credit card donation in the amount of \$35 from Gary Tennesson that was inadvertently left out of the original report. Neither of these donations affected the itemized Schedule B.

A refund from Charter Communications in the amount of \$112.59 was removed from the Other Receipts (Line 15) as this was an erroneous entry. In addition, line 15 was increased by \$.22 for unreported interest on savings account.

The 3/31/14 Paycheck to Carla Bayerl was understated by \$70 (original page 24). This amount has been corrected on Schedule B.

No changes were made to the report. The new Summary Pages reflecting the correct election cycle to date totals are attached.




