

As stated in our reports, the Plumbers & Pipefitters Local Union 74 Political Action Committee receives contributions from the members of Local Union 74. If you take the highest average contribution of \$3.94 and multiply by 12 months the average total contribution per year is \$47.28.

PAC monies are deducted from the members' paychecks at a rate of \$.025 per hour worked. If you work 40 hours a week your PAC contribution would be \$1.00 weekly, and \$52.00 yearly.
