Dear Mr. Deeker:

I'm responding to your letter of August 26 with regard to three contributions to the WheatPAC financial account. Following up on your letter, we have taken the following actions.

1. The \$1700 contribution attributed to the Kansas Association of Wheat Growers (KAWG) was paid with the association's company card, and has been refunded to KAWG. A copy of the check is enclosed.
2. The \$1500 contribution attributed to the Minnesota Association of Wheat Growers was paid for with a personal credit card belonging to Chad Anvinson, a member of the association. He purchased it on behalf of the association, but used his personal credit card to make the payment.
3. The checks from Hammes Farm Partnership, totaling \$262.50, have been refunded to them. A copy of the check is enclosed.

We have also revised our protocol for conducting the annual auction event, with the goal of further tightening our procedural control over payments for auction items.
