This letter is prompted by the Commission's preliminary review of the report(s) referenced above. The review raised questions concerning certain information contained in the report(s). An itemization follows:

-Line 11(a)(i) of the Detailed Summary Page of your report discloses a total of \$1,227.78 in itemized contributions from individuals. The sum of the entries itemized on Schedule A, however, indicates the total to be \$806.28. Please amend your report to clarify the discrepancy.

-Line 23 of the Detailed Summary Page of your report discloses a total of \$11,798.11 in contributions to federal candidates/committees and other political committees. The sum of the entries itemized on Schedule B, however, indicates the total to be \$2,500. Please amend your report to clarify the discrepancy.

A written response or an amendment to your original report(s) correcting the above problem(s) should be filed with the Federal Election Commission within fifteen (15) days of the date of this letter.
