I have received a request to file financial disclosure statements for the 2014 federal election cycle, pursuant to the rules of the Committee on Ethics. However, as I informed Ms. Janice L. Glosson from your office in a telephone conversation held on June 8, I am currently not a candidate for the U.S. House of Representatives and will not run either in 2014 or 2016. I was, nonetheless, a candidate for the House in 2012 and lost the election. Since the 2012 election, the committee (Cox Alomar 2012 Inc.), as reflected in its FEC reporting, has been raising funds to pay off outstanding debt from the 2012 campaign.

I would greatly appreciate if you could update your records accordingly. I am copying here the staff at the FEC.

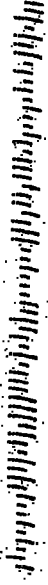
