This letter is prompted by the Commission's preliminary review of the report(s) referenced above. This notice requests information essential to full public disclosure of your federal election campaign finances. **An adequate response must be received at the Commission by the response date noted above.** An itemization of the information needed follows:


-Your Statement of Organization indicates in Line 5(b) that you are an authorized committee of a candidate under 2 U.S.C. § 432(e)(1) to receive contributions or make expenditures on behalf of such candidate. However, your committee appears to be a party committee. Please amend your Statement of Organization to clarify this apparent discrepancy.

Please be advised if your committee has not been authorized by a candidate to act on their behalf as evidence on their Statement of Candidacy, please do not check the box for Line 5(b). However, if your committee is responsible for the day-to-day operation of a political party, then please complete the information for Line 5(d). Please refer to 2 U.S.C. §433 and 11 CFR §102.2 and the instructions for the Statement of Organization (FEC FORM 1) for further information.

-Please clarify your relationship, if any, with California Republican Party, which appears to be an affiliated committee. For further guidance on the question of affiliation, please refer to 11 CFR §100.5(g) and §110.3. If your committee is affiliated with California Republican Party you should amend your Statement of Organization to reflect this relationship as "affiliated" on Line 6.

Unlike previous election cycles, you will not receive an additional notice from the Commission on this matter. Adequate responses received on or before this date will be taken into consideration in determining whether audit action will be initiated. **Requests for extensions of time in which to respond will not be considered.** Failure to provide an adequate response by this date may result in an audit of the committee. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action. Electronic filers must file amendments (to include statements, designations and reports) in an electronic format and must submit an amended report in its entirety, rather than just those portions of the report that are being amended.
