The original Form 1 filing for the National Defense Committee PAC incorrectly listed the PAC as a Seperate Segregated Fund (SSF) of an organization named the National Defense Committee. This amended Form 1 removes that notation. While these organizations share a common name and were started by the same individual, there is no relationship of control, management, oversight, financing, or otherwise between the two entities, and they are operated as wholly seperate and unaffiliated entities. Additionally, this amended Form 1 indicates an affiliation between this PAC and the National Defense PAC (C00359992), which is simultaneously amending it's Form 1 to indicate this affiliation. Both PAC's share the same Treasurer and some circumstances indicating affiliation such that we will treat both PAC's as affiliated pending an Advisory Opinion request & response to the contrary.
