Dear Treasurer:

This letter is prompted by the Commission's preliminary review of the report(s) referenced above. This notice requests information essential to full public disclosure of your federal election campaign finances. **Failure to adequately respond by the response date noted above could result in an audit or enforcement action.** Additional information is needed for the following 7 items:

1. Schedule A-P of your report discloses one or more contributions that appear to exceed the limits set forth in the Act (see Attachment #1). You should examine all of your contributions to check for additional excessive contributions. The Committee's procedures for processing contributions should also be reviewed.

An individual or a political committee other than an authorized committee or qualified multi-candidate committee may not make a contribution to a candidate for federal office in excess of \$2,300 per election. An authorized committee may not make a contribution to a candidate for federal office in excess of \$2,000 per election. A qualified multi-candidate committee and all affiliated committees may not make a contribution(s) to a candidate for federal office in excess of \$5,000 per election. The term "contribution" includes any gift, subscription, loan, advance, or deposit of money or anything of value made by any person for the purpose of influencing any election for federal office. (2 U.S.C. §§ 441a(a) and (f); 11 CFR §§ 110.1(b), (e) and (k))

If any apparently excessive contribution in question was incompletely or incorrectly disclosed, you must amend your original report with the clarifying information. If any contribution you received exceeds the limits, you may have to refund the excessive amount.

Excessive contributions may be retained if, within sixty (60) days of receipt, the excessive portions are properly redesignated or reattributed. Guidelines for each option are provided below:

For reattributions, excessive contributions from individuals can be retained if, within sixty (60) days of receipt, the excessive amount is properly reattributed to another person. Please note that reattributions only apply to excessive contributions from individuals. An excessive contribution is considered properly reattributed if (1) the contributors provide the committee with written documentation, signed by each contributor, authorizing a reattribution and indicating the amount of the contribution to be attributed to each contributor, or (2) the committee reatributes, by presumption, the excessive portion of the contribution if the contribution was made on a written instrument from a joint account and was signed by only one of the account holders. In this case, the treasurer must notify the contributors in writing within 60 days of receiving the contribution that the committee intends to reattribute the excessive portion and must give the contributor an opportunity to request a refund. (11 CFR § 110.1(k)(3)(ii)(B))

For redesignations, the funds can be retained if within sixty (60) days of receipt the excessive amount is properly redesignated for a different election. An excessive contribution is considered properly redesignated if (1) the committee obtains signed written documentation from the contributor(s) authorizing the redesignation of the contribution for another election, provided that the new designation does not exceed the limitations on contributions made with respect to that election, or (2) your committee redesignates by presumption the excessive portion of the contribution for another election provided that the new designation does not exceed the limitations on contributions made with respect to that election. In this case, the treasurer must notify the contributor of the redesignation in writing within 60 days of the treasurer's receipt of the contribution. The notification must give the contributor an opportunity to request a refund. (11 CFR § 110.1(b)(5)(ii)(B)) Please note that you cannot presumptively redesignate an excessive contribution from a multi-candidate committee. Also, a contribution can only be redesignated to a previous election to the extent that the contribution does not exceed the committee's net debts outstanding for that election. (11 CFR § 110.1(b)(3)(i))

If the foregoing conditions for reattributions or redesignations are not met within 60 days of receipt of the contribution, the excessive amount must be refunded. See 11 CFR § 103.3(b)(3).

Please inform the Commission of your corrective action immediately in writing and provide photocopies of any refund checks and/ or letters reattributing or redesignating the contributions in question. Refunds are reported on Line 28 of the Detailed Summary Page and on a supporting Schedule B-P of the report covering the period in which they are made. Redesignations and reattributions are reported as memo entries on Schedule A-P of the report covering the period in which the authorization for the redesignation and/or reattribution is received. (11 CFR §§ 104.8(d)(2), (3) and (4))

The acceptance of excessive contributions is a serious problem. Again, the committee's procedures for processing contributions should be examined and corrected in order to avoid this problem. Although the Commission may take further legal action, prompt action by you to refund, redesignate, and/or reattribute of the excessive amount will be taken into consideration.

2. In addition to the excessive contributions cited in Attachment #1, it appears that your committee has general election contributions in your cash on hand that have not yet been refunded, redesignated, or reattributed. While committees can receive general election contributions before the primary election has occurred, if the candidate does not participate in the general election these general election contributions must be refunded or redesignated within 60 days of the date the candidate withdraws from the race or loses the primary election. (11 CFR § 102.9(e)(3)).

Any subsequent report(s) filed with the Commission must disclose the refund or redesignation of any general election contribution. Refunds or redesignations must be done within 60 days after the candidate withdraws from the race or loses the primary election.

Please amend your report to disclose what action will be taken in regard to the general election contributions received by your committee.

3. Line 24 discloses a transfer to Friends of Hillary that is designated "P2008." Please be advised that:

a) If "P2008" refers to the primary election, please be advised that your committee cannot at this time simply transfer to Friends of Hillary contributions that were received for the primary election, because your committee has net debts outstanding for the presidential primary election. (11 CFR § 116.2(c)(2)) If the funds transferred to Friends of Hillary were contributions designated for the presidential primary election, and were not transferred to effect a written redesignation (see below), they must be transferred back to your presidential committee and disclosed on your reports.

b) We also note some memo entries associated with this transfer that are designated "G2008." If "G2008" refers to the general election, please be advised that you cannot simply transfer to Friends of Hillary contributions that were received for the general election, because Senator Clinton was not a candidate in the general election. While committees can receive general election contributions before the primary election has occurred, if the candidate does not participate in the general election these general election contributions must be refunded or redesignated within 60 days of the date the candidate withdraws from the race or loses the primary election. (11 CFR § 102.9(e)(3)). In Senator Clinton's case, this means that the general election contributions had to be refunded or redesignated no later than August 6, 2008. If the funds transferred to Friends of Hillary were contributions designated for the presidential general election, and they were not transferred to effect a written redesignation (see below), they must be transferred back to the presidential committee and disclosed on your reports. Once the transfer back is received, each contribution must be refunded to the original contributor immediately.

c) To the extent funds are available, your committee may transfer funds to Friends of Hillary to effect written redesignations, executed by contributors, to the 2012 Senate primary or general election. (11 CFR §§§§ 102.9(e)(3), 110.1(b)(5), 110.2(b)(5), and 110.1(l)) These redesignations must be disclosed as memo entries on Schedule A-P. (11 CFR 104.8(d)(2)) When your committee disburses these contributions to Friends of Hillary, you should disclose it on Line 29, "Other Disbursements." The purpose of disbursement should explain that committee funds were redesignated by contributors to the 2012 Senate committee. If your committee discloses redesignations to the 2012 Senate election, please confirm via Miscellaneous Text Submission (FEC Form 99) that the committee has received written redesignations for each of the contributions that were sent to Friends of Hillary.

Please clarify the nature of the Line 24 transfer to Friends of Hillary and amend your report to correctly disclose these transactions.

4. Schedule B-P, supporting Line 28(a), discloses refunds to individuals. It appears that your committee has not reported the receipt of the original contributions, has received original contributions that are designated to different elections than the refunds, or has refunded an amount greater than the original contribution (see Attachment #2). Please clarify these refunds and amend your report(s) as necessary. (2 U.S.C. § 434(b) and 11 CFR § 104.3(a))

5. Debt payments for this period (Schedule D-P) are greater than the payments itemized on Schedule B-P. Each expenditure to a person, which in the aggregate exceeds \$200 for the election cycle, must be reported on Schedule B-P. "Person" includes an individual, partnership, corporation, association, and public or private organization -- other than an agency of the United States Government. Please amend your report to correct the discrepancies in the payments made to Event Production, LLC. (11 CFR §§ 100.10 and 104.3(b)(4)(i))

6. Your report discloses the following "Offset to Operating Expenditure" on Schedule A-P supporting Line 20(a). However, your reports do not disclose an original disbursement to this entity. Please be advised that if there are not corresponding expenditures for these entries, they may constitute excessive or prohibited contributions. Please amend your report to provide an explanation for this entry. (11 CFR § 104.3(a)(4)(v))

7. Please be advised that purposes listed for debts on Schedule D-P differ from purposes listed for payments on these debts on Schedule B-P (see Attachment #3). For example, a debt owed to a staffer for the purpose of "travel" has a corresponding payment on Schedule B-P that lists the purpose as "salary."

If any of these disbursements were actually for the purpose of "travel," these disbursements must be itemized as follows: When the reimbursement amount to staff for travel and subsistence advances exceeds \$500, the payments by staff to any one vendor that make up the reimbursement may have to be itemized. For example, if the campaign related payments to any one vendor by the campaign/staff aggregate in excess of \$200 for the election cycle, the staff advance payment to the vendor must also be itemized in a memo entry for that reimbursement. Each memo entry must include the complete name and address of the original vendor, as well as the date, amount and detailed purpose of the advance. If itemization is not necessary for a particular reimbursement to staff in excess of \$500, you must indicate so in an amendment to this report. (11 CFR § 104.9)

Additionally, when a payment is made to reduce or extinguish an obligation owed by the committee, the payment must be itemized on Schedule B-P, reported on the appropriate line of the Detailed Summary Page, and included in the "Payment This Period" column on Schedule D-P. The "Payment This Period" should only include payments to reduce that debt during the reporting period. For further guidance, please see the "Instructions for Schedule D-P Debts and Obligations (Form 3P)."

Please explain the differences between debt purposes and debt payment purposes listed on Attachment #3 and amend your report to reflect the necessary changes.

Please note, you will not receive an additional notice from the Commission on this matter. Adequate responses must be received by the Commission on or before the due date noted above to be taken into consideration in determining whether audit action will be initiated. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action. **Requests for extensions of time in which to respond will not be considered.**

Electronic filers must file amendments (to include statements, designations and reports) in an electronic format and must submit an amended report in its entirety, rather than just those portions of the report that are being amended.
