-Your calculations for Line 8, Column B, appear to be incorrect. FEC calculations disclose this amount to be \$11,672.85. Please provide the corrected total on the Summary Page.

-Your calculations for Line 23, Column B, appear to be incorrect. FEC calculations disclose this amount to be \$4,700. Please provide the corrected total on the Detailed Summary Page.



Contributions to non-federal candidates and committees should be itemized on Schedule B supporting Line 29.
