
Attached is a photocopy of the refund request sent to the recipient. Further, we will disclose the refund when received as directed.


The Federal Election Commission has informed us that we exceeded the legal allowable contribution to your 1994 Campaign Drive for Congress. Perry PAC does not qualify as a multi-candidate committee and therefore, is restricted to a maximum of \$1,000.00 per election to a candidate's campaign. Reference is made to ACT. 2 U.S.C. 441a(a) of the Federal Election Campaign Act.

On September 29, 1994, and October 14, 1994, we made contributions of \$2,000.00 (check number 120) and \$500.00 (check number 133) respectfully, to your campaign. As required by law, we regrettably ask that the over-contribution of \$1,500.00 be refunded to Perry Manufacturing Company Political Action Committee.
