In response to the further inquiry of the FEC as to the Amended February Monthly Report, with respect to attachment page 1 of that RFAI, the transactions made to Google on 1/1/2012 in the amount of \$33,831.42, Smiley Media on 1/1/2012 in the amount of \$33,221.45, and StumbleUpon on 1/1/2012 in the amount of \$565.40 - all for election code P2012-IA on the report received on 1/3/2012 - were originally timely reported on FEC filed report #756126, then amended by report #756167, and amended further by report #773676. Because these amendments appear to not have entered the FEC File system properly as amendments to the prior reports, they do not correspond to the actual Amended February Report which lists these transactions properly at pages 43, 73, and 82 (respectively). These transaction also correspond to the transactions on Attachment Page 3 to Google on 1/1/2012 in the amount of \$33,817.30 (amended amount), Smiley Media on 1/1/2012 in the amount of \$34,882.53 (amended amount), and StumbleUpon on 1/1/2012 in the amount of \$565.40 - all for election code P2012-IA. It appears that because the amended report did not properly amend the original report, duplicate transactions were thus created. **On Attachment Page 1, the transactions made on 1/9/2012 to Google in the amount of 27462.84, Smiley Media in the amount of 10,431.48, Smith's in the amount of 12.84 and StumbleUpon in the amount of 1,785.05 for election P2012- NH, and the identical transactions listed on Attachment page 3, these transactions were originally disclosed on FEC report #756877 on 1/10/2012, subsequently amended by Report #773674 on 4/6/2012, and additionally amended by report #786548 on 5/24/2012, including corrections to contents and amounts. These items are disclosed on the amended February monthly report at pages 47, 77, 80, and 86 respectively. Because of what appears to be an error uploading these subsequent reports, they do not appear to have properly entered the FEC filing system as amendments to the original report. **On Attachment Page 1, the transaction made to Google on 1/7/2012 in the amount of 31,485.37 for election P2012-IA on the report received on 5/24/2012 (page 46 of the amended February report) was originally reported on 1/08/2012 on FEC report #756672, subsequently amended by FEC report #773670, and further amended on FEC report #786571. The amended report(s) did not properly upload as an amendment. **On Attachment Page 3, the transactions made on 1/3/2012 to Chris Hanson in the amount of 300.00, Google in the amount of 32,714.93, Smiley Media in the amount of 27,109.77, and StumbleUpon in the amount of 2,833.45 for election P2012-IA was originally reported on report #756317 filed January 4,2012, and was subsequently amended by report 773675 for election P2012-IAin the same amounts and days except for the amended amount to Smiley Media. An additional amendment correctly re-designating these transactions as being for P2012-NH, and corresponding respectively to pages 59, 44, 74 and 83 of the amended February report was closed on 5/23/2012 but failed to upload. An attempt to upload that amendment today failed due to a technical issue requiring consultation with FEC technical support. **On Attachment Page 3, the transaction made to Ridley's on 1/20/2012 in the amount of 7.69 for election P2012-SC, located on page 72 or the amended February report, was originally reported on 1/19/2012 on FEC report #758501, and subsequently on an amended report #786154 filed on 5/23/2012. The amended report did not properly upload as an amendment. **On Attachment Page 3, the transaction made to WHDT on 1/14/2012 in the amount of 94,188.00 for election P2012-SC, located on page 100 of the amended February report, was originally reported on 1/24/2012 on FEC report #759303 (as two separate transactions), and subsequently on an amended report #786148 filed on 5/23/2012. The amended report did not properly upload as an amendment.

Page 4, the transaction made to Facebook on 1/16/2012 in the amount of 778.29 for election P2012-FL(page 34 of the amended February report) and to Facebook on 1/16/2012 in the amount of 18,270.57 for election P2012-SC (page 35 of the amended February report) were originally reported as being paid to SmileyMedia for FaceBook advertising on 1/16/2012 on FEC report #757929 and included funds for several additional expenditures via FaceBook. Because of the pass-through nature of this particular transaction, the expenditure was subsequently broken up into its component parts, including for jurisdictions where the threshold for reporting was not met. **On Attachment Page 4, the transaction made to Plaid Social on 1/17/2012 in the amount of 6,037.83 for election P2012-SC (page 69 of the amended February report) was for a video intended to be used, and reported as such, but that did not in fact air. **On Attachment Page 4, the transaction made to StumbleUpon on 1/13/2012 in the amount of 431.60 for election P2012-SC (page 88 of the amended February report)

) was originally reported on 1/14/2012 on FEC report #756617, subsequently amended by FEC report #786146. The amended report did not properly upload as an amendment.
