

Dear Ms. Scindian:

It was recently brought to our attention that the occupation and employer given for two contributions received by the Mark Pryor for U.S. Senate Campaign from Mr. Kirk Robertson were incorrectly listed on reports the campaign filed with the Federal Election Commission. Mr. Robertson's correct occupation and employer should have been listed as outlined below.

On December 19, 2001, Mr. Robertson made a contribution of \$300 to the campaign. At the time, he was self employed. His occupation should have been listed as "consultant."

On July 25, 2002, Mr. Robertson made a \$600 contribution to the campaign. At that time he was employed by Baker, Donelson. His occupation should have been listed as "advisor."

The Mark Pryor for U.S. Senate Campaign Committee has reviewed its procedures for reporting the occupation and employer of its contributors to ensure that this type of error does not occur in the future. 
