Thank you for your letter of December 8, 1995 advising that you have now accepted the termination report for ODECO PAC (Identification Number c00174136). As noted in my letter of November 17, 1995, subsequent to the ODECO PAC termination, we wish to change the sponsoring organization for MURPAC to Murphy Oil Corporation.

Also, MURPAC now has a new Treasurer, Kevin G. Fitzgerald. Timothy F. Butler will serve as Assistant Treasurer.

I have enclosed an Amended Statement of Organization reflecting these changes.

Finally, in reviewing the Commission's Campaign Guide for Corporations and Labor Organizations (December 1994), I note that, beginning in 1994, the Commission requires Notification of Multicandidate status via a Form 1M. MURPAC qualified for multicandidate status prior to January 1, 1994 and it is my understanding that the designation on our Form 3X is therefore sufficient. However, if I am in error please advise and I will supply you with a Form 1M.
