Thank you for taking the time to speak to me today to clear up any filing discrepancy of the Alabama Credit Union Legislative Action Council (ACULAC). Enclosed, please find the Quarterly Report for January 1, 2006 to March 31, 2006.

As I stated during our conversation today, my records indicated that the report was prepared and sent on April 10, 2006, and was used in preparing the 2nd Quarterly Report of the year. While I am sure that your office sent a notice that the 1st Quarterly Report was late, I did not receive it, and therefore did not realize that the report was not on file with the FEC until receiving the notice of October 11th. Rest assured that this was not an attempt to withhold information, nor even an effort to simply avoid the filing requirements. This was an honest mistake, and one that I will make every effort to avoid having happen again.

Our PAC is small compared to most, and is something that I manage part time, but none the less to the best of my abilities. I have consistently worked to ensure that all guidelines regarding PAC activity, including timely reporting, are followed. To help ensure that the mistake regarding the 2006 First Quarterly Report does not happen again, our PAC will begin using electronic filing in 2007. We will follow your suggestion that we do not make the change until a new year, and will complete the remainder of 2006 with paper filings.
