Dear Treasurer:

This letter is prompted by the Commission's preliminary review of the report(s) referenced above. This notice requests information essential to full public disclosure of your federal election campaign finances. **Failure to adequately respond by the response date noted above could result in an audit or enforcement action.** Additional information is needed for the following 2 items:

1. Schedule A supporting Line 11(a)(i) of your report discloses receipts identified as "Cash, Cash" totaling \$5,450. Please be advised that contributions exceeding \$100 must be made by check (or other written instrument). 11 CFR §110.4(c) Please return any amount over \$100 to each contributor and disclose the refunds on the appropriate report(s).

However, if these apparent cash contributions did not exceed \$100 per contributor, you are advised that all contributions from individuals/persons that aggregate greater than \$200 in the calendar year must be itemized on Schedule A supporting Line 11(a)(i). Contributions from individuals/persons that aggregate \$200 or less need only be disclosed on Line 11(a)(ii) of the Detailed Summary Page. 11 CFR §104.3(a)(2) Please amend your report to clarify these apparent discrepancies.

2. Schedule A of your report discloses contributions from political committees that fail to include a full and/or recognizable name. Reporting only the name of the connected organization, abbreviating the name of the committee so it is unrecognizable, or using an indistinguishable acronym is inadequate. The following committee names from your report need

further clarification: "IBT DRIVE - 312, IBT DRIVE- 312," "IBT DRIVE - 676, IBT DRIVE - 676," "Teamsters LU 384 PAC, TLU 384 PAC," "Teamsters LU 500 PAC, TLU 500 PAC," "Teamsters LU 623 PAC, TLU 623 PAC," "Teamsters LU 77 PAC, TLU 77 PAC," and "Teamsters LU 830 PAC, TLU 830 PAC."


Please amend your report to include the missing information. 11 CFR §§100.12, 102.14(c) and 104.3(a)(4)(ii)

- Your report disclosed certain categories of financial activity that have been reflected on the wrong lines of the Detailed Summary Page. Contributions from other political committees and Contributions to non-federal candidates/committees should be properly disclosed on a separate Schedule(s) A and B, supporting Line(s) 11(c) and 29 respectively of the Detailed Summary Page. Please refer to the instructions for each line when determining the proper categorization(s) for your next filing.

**Please note, you will not receive an additional notice from the Commission on this matter.** Adequate responses must be received by the Commission on or before the due date noted above to be taken into consideration in determining whether audit action will be initiated. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action. **Requests for extensions of time in which to respond will not be considered.**

Electronic filers must file amendments (to include statements, designations and reports) in an electronic format and must submit an amended report in its entirety, rather than just those portions of the report that are being amended.
