City Attorney Jan Goldsmith 2012 Committee (the "Committee") is the official city campaign committee for San Diego City Attorney, Jan Goldsmith. Pursuant to Federal Election Commission (the "Commission") guidance provided by the Commission's Information Division, we are hereby registering the Committee as a federal independent expenditure-only committee for the purpose of making a contribution to an existing independent expenditure-only committee (the "Super PAC").

As explained by the Information Division, because the Committee intends to contribute in excess of \$5,000 to an FEC-registered Super PAC, it is unable to register as a regular non-connected federal Committee and must instead register as a federal independent expenditure-only committee. Once registered as a federal independent expenditure-only committee, the Committee will not use its funds to make contributions, whether direct, in-kind, or via coordinated communications, to federal candidates or committees. The Committee intends to file a termination report with the Commission shortly after making its contribution to the Super PAC.
