Dear Mr. Davis:

The following information is provided in response to the subject letter, a copy of which is included for your reference:

- The Schedule H1 missing from our February report is provided as enclosure (1) to this letter. As I mentioned during our conversation this morning, Schedules H1 may be absent from other NatPAC filings for 1997. For the purposes of any such filings, the applicable Federal/ Non-Federal ratio is 87/13. We will submit Schedules H1 with all future FEC filings.
- An amended Schedule B supporting line 23 is provided as enclosure (2) to this letter. The disbursement to Chris Cannon should have been designated for 1996 Debt Retirement rather than as a General Election contribution. We regret the confusion caused by our original reporting.

This letter is prompted by the Commission's preliminary review of the report(s) referenced above. The review raised questions concerning certain information contained in the report(s). An itemization follows:

-Your report does not include a Schedule H1 to disclose the ratio for the allocation of administrative and generic voter drive costs. This ratio is determined at the beginning of each two-year election cycle. All shared administrative and generic voter drive costs incurred during the two-year cycle must be allocated according to this ratio, unless the federal account elects to pay a higher percentage of its cost. 11 CFR §106.5(b)(2), (d)(1), (d)(2) and 11 CFR §§104.10(b)(1)(ii)(B) and 106.6(c)

-Schedule B supporting Line 23 of your report discloses a contribution(s) to a candidate(s) for the 1996 General election; however, the funds were disbursed after the election date(s) (pertinent portion(s) attached). Please note that contributions may not be designated for an election which has already occurred unless the funds are to be used to reduce a candidate committee's debts incurred during that election campaign. Please clarify the contribution(s) and disclose any redesignations or refunds as necessary on the appropriate schedules.

A written response or an amendment to your original report(s) correcting the above problem(s) should be filed with the Federal Election Commission within fifteen (15) days
