

Thank you so much for your inquiry re Bill's campaign for re-election to the U.S. Senate. In checking our records we discovered two records for JM Family Enterprises. One as JM Family and one as J.M. Family and our search for duplicate records did not pick it up.

Enclosed please find our check 3535 in the amount of \$4000. Federal law limits contributions to \$5000 for the primary and \$5000 for the general election. On 7/18/01, JM Family Enterprises Inc., PAC contributed \$1000 towards the primary, on 3/4/02 an additional \$1000 for the primary, on 4/29/02 \$2000 for the primary and on 5/31/05 \$5000 for the primary and \$5000 for the general. Since check #469 dated 5/31/05 was for \$5000 for the primary election, you have exceeded the contribution limit by \$4000 for the 2006 campaign cycle.
