Dear Ms. Kitchen:

In reply to your letter of December 13, 2000, concerning our July Quarterly Report for Justice PAC.

- 1.) Concerning the Schedule B supporting Line 23 which designates a contribution for Walter Jones for Congress. The designation for the primary was in error. It should have indicated that the contribution was for the general election.
- 2.) Regarding Schedule A supporting Line 17, the payment from Omega List Company is list rental income. Omega List Company is a well-established company in the list rental business and all payments we receive from them are the results of income generated by the rental of our mailing list on the open market. Therefore, the monies we receive from them cannot be construed as a contribution or as the receipt of any goods or services without charge or at a charge which is less than the usual and normal charge for such goods or service.
- 3.) Concerning amending the Schedule B supporting Line 23 to include the office sought for each contribution made, that information is already listed for each contribution at the bottom of the box for the Full Name, Mailing Address and ZIP code. Since there isn't a box designated for office sought, please advise if I should place that information into a different box in the future.
- 4.) Attached is an amended Schedule A supporting Line 17 which includes the aggregate year-to-date totals.
