This letter responds to your RQ-2 to the Next Generation regarding clarification of administrative expenses. Next Generation paid \$3,708.97 in administrative and legal expenses for the fourth quarter of 1997. These payments were made to Petree Press for office items. In addition, the PAC paid Nancy Jacobson \$7,652.25, part of which included payment for administrative services such as maintaining books and reports. In the first quarter of 1998, Next Generation paid \$1,514.00 to Skadden Arps. Skadden Arps maintains books and records and performs administrative tasks for the PAC. In addition, in the first quarter of 1998, Next Generation paid Nancy Jacobson \$2,000.00, a portion of this covered administrative expenses. Finally, in the second quarter of 1998, Next Generation paid \$582.81 to Petree Press for stationery and again, part of the \$4,719.48 paid to Nancy Jacobson in consulting fees included the provision of administrative services.
