- Line 16 of the Detailed Summary Page of your report discloses a total of \$1,200 in refunds of contributions made to federal candidates and other political committees. The sum of the entries itemized on Schedule A, however, indicates the total to be \$0. Please amend your report to clarify the discrepancy. (52 U.S.C. §30104(b) and 11 CFR §104.3)

**Please note, you will not receive an additional notice from the Commission on this matter.** Adequate responses must be received by the Commission on or before the due date noted above to be taken into consideration in determining whether audit action will be initiated. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action. **Requests for extensions of time in which to respond will not be considered.**

Electronic filers must file amendments (to include statements, designations and reports) in an electronic format and must submit an amended report in its entirety, rather than just those portions of the report that are being amended.
