Dear Mr. Davidson:

This letter is prompted by the Commission's preliminary review of the report(s) referenced above. The review raised questions concerning certain information contained in the report(s). An itemization follows:

- The beginning cash balance of this report should equal the ending balance of your Amended October Monthly Report (9/1/01-9/30/01), received 4/16/02. Please clarify this discrepancy and amend any subsequent report(s) that may be affected by this correction.
- The totals listed on Lines 6(c), 7, 11(a)(iii), 23, and 29, Column B of the Summary and Detailed Summary Page(s) appear to be incorrect. Please be advised that you should add the "Calendar Year-to-Date" total from your previous report to the current "Total This Period" figure from Column A to derive the correct Column B totals. Please amend your report and any subsequent reports that may be affected by this correction.
- Your calculations for Lines 11(d), 19, 20, 28(d), 30, and 31, Column B appear to be incorrect. Please provide the corrected totals on the Detailed Summary Page.
- Line 28(a) of the Detailed Summary Page of your report discloses a total of -\$500 in Refunds of Contributions to Individuals. The sum of the entries itemized on Schedule B, however, indicates the total to be \$0. Please amend your report to clarify the discrepancy.

-Schedule B supporting Line 28(a) of your report discloses apparent voided contribution(s) to federal candidate/committee(s). Voided contribution(s) to federal political committee(s) should be itemized on Schedule B supporting Line 23 of the Detailed Summary Page as a negative entry. Line 28(a) is for refunds of contributions received from individuals. Please amend your report to clarify if these are voided contributions received from committees. In case of the latter, a refund of a contribution(s) received from a federal political committee(s) should be properly itemized as a positive entry on Schedule B supporting Line 28(c) of the Detailed Summary Page.

A response or amendment to your original report(s) correcting the above problem(s) should be filed with the Federal Election Commission within fifteen (15) days of the date of this letter. Electronic filers must file amendments (to include statements, designations and reports) in an electronic format and must submit an amended report in its entirety, rather than just those portions of the report that are being amended.
