
This letter is in response to your request for additional information dated November 3, 1999. After reviewing your letter and our report and communicating directly with you on November 8, we have taken the following actions. We hope they will resolve your concerns:

- 1) On November 12, 1999, we transferred a total of \$13,409 from our federal account to our non-federal account (copies of the check and deposit receipt are enclosed). This transfer is intended to correct transfers made in error from the non-federal account to the federal account related to certain fundraising expenses. All or a portion of each had been reported on Schedule H3 outside the 70-day period for timely transfers:
 - Kansas Day Reception, \$2,408
 - Emergency Letter, \$9,683
 - Governor's Grand Club, \$1,250
 - Shadow Glen GGC, \$68
- 2) We have enclosed sample versions of the computer-produced formats of our reporting schedules and forms for your approval. These reports were generated by FECFile, Version 3.00, software obtained from the Federal Election Commission in April 1999. Please let us know whether we can continue using the forms generated by that software.
