Your letter from January 11, 2007: In the months of January 2007 to March 2007 none of our employees spend 25% or more of their time on FEA or activities in connection with a Federal election and their salaries were paid from our nonfederal account. 2. The transfer in of \$ 16,829.72 from the non-federal account for allocated activity was for the time period 11/28/06 to 12/31/06 and was based on \$ 19,799.67 joint expenses. . The transfer in of \$ 57,090.43 from the non-federal account for allocated activity was for the time period 1/1/07 to 2/28/07 and was based on \$ 67,165.18 joint expenses. However, the wrong percentage rate for the federal portion of these amounts was used. We refunded the overpayment on 10/31/07 and reported it with our November 2007 report. 3. The payments on Schedule H4 for federal and state payroll taxes, health insurance, insurance, ITEMIZE: insurance, and net pay were for employees who did not spend 25% or more of their time on FEA or activities in connection with a Federal election. 4. The payments for contract labor/janitor were made to an individual who is not our employee. He is a self employed individual who has a janitorial service and other clients and we hired him to clean our offices. 5. We have amended the report to show the proper allocation ratio on schedule H 1 and H4. Furthermore, we have repaid the overpayment to our nonfederal account on October 2007 and reported this in our November 2007 report. .
