Dear Mr. Jones:

This letter is being submitted in response to the Request for Additional Information ("RFAI") dated December 21, 2014. The RFAI identified 5 contributions dated 10/16/2014 on a 48-Hour notice, which were not disclosed on Schedule A of the Post-General report.

As you know, the Pre-General report covers a date range ending on 10/15 and the Post-General covers a date range beginning on 10/16. The five contributions in question fall right on the ending and beginning dates of these reports, respectively.

The date used on the 48-hour report (10/16) was incorrect. The five contributions were disclosed on the Pre-General report and were correctly dated 10/15. As you identified, the contributions were not disclosed on the Post-General report.

In summary, the Pre-General and Post-General reports were correct. The dates of the five contributions on the 48-hour notice were incorrect. If you would like us to file a revised 48-hour report, please let us know.

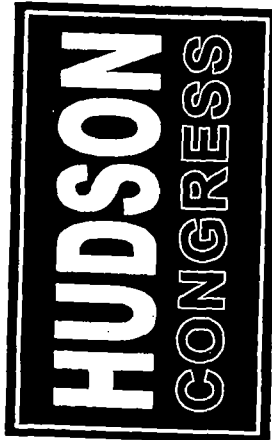
