

Consistent with the U.S. Court of Appeals for the District of Columbia Circuit decision in *Speech Now v. FEC*, and the stipulated judgment in *Carey v. FEC*, (D.D.C. 2011), the Committee intends to raise funds in unlimited amounts from individuals, corporations, labor organization and/or other political committees. The Committee will not use the funds to make contributions, whether direct, in-kind or for the coordinated communications or coordinated expenditures, to federal candidates or committees.
