
Upon filing the accompanying FEC Form 3X report for the period 10/14-11/22/04, its first ever and only Federal report, Rockbridge Area Republican Committee wishes to terminate its registration and reporting obligations inasmuch as it no longer intends to receive contributions, make expenditures, or make any disbursements that would otherwise qualify it as a political committee.

As a local party organization, the Rockbridge Area Republican Committee has never historically spent funds in support of a Federal candidate. We applied for status in October only because Federal law, as we understood it, required us to report an independent expenditure in support of a Federal candidate exceeding \$1,000. During the week of the election, we purchased \$1,295 in local media advertising in behalf of the re-election of George W. Bush. Contributions received for the general operation of our headquarters, and not necessarily for the advertising indicated above, did not approach the \$5,000 Federal threshold.

Residual funds, carried both forward to and beyond the reporting period were, and continue to be, used for the purpose of maintaining our local organization business and operational affairs, including office supplies, committee newsletters, scholarships for local high school students, and the future support of local political candidates. The committee has no outstanding debts or obligations and is not involved in an enforcement action, an audit or litigation with the FEC.

The accompanying report on Form 3X contains, we believe, the required summary of all receipts and disbursements in connection with the 10/14-11/22 reporting period. We have no intent of making future expenditures in support of any Federal candidate at any time, and thereby request termination of our registration and further reporting obligations.


