Upon completing an internal audit, it was discovered that Cal PAC reported an excessive number of disbursements to Mr. Terrance Bronowski for his accounting services. Between 2003 and 2008, the total amount of excessive payments to Mr. Bronowski added up to \$6,000. A negative disbursement is being reported to reflect the aggregate total of excessive disbursements that were reported to Mr. Bronowski but never cleared the bank.
