This memo follows on discussions held with Federal Election Commission Staff (FEC) staff last month. We recently audited our PAC banking accounts and our reports to the FEC. This was the first time a reconciliation between the two had occurred since early in 2015. We were reporting \$98.01 more to the FEC than we actually had in our banking account. This discrepancy was probably due to banking charges. We have listed this as a \$98.01 disbursement on our September 20, 2016 filing for August 2016.
