Please find enclosed the original of FEC Form 3X (including Schedules A, B, C, D & E) consisting of 21 pages, which has been prepared for, and signed by Barbara DeGroot Nichols, Treasurer of Citizens To Save America. (hereinafter referred to as "CTSA").

CTSA was organized in October, 2012, as a Colorado nonprofit corporation for the sole purpose of purchasing and launching a helium-filled balloon with printed side banners which stated 'ROMNEY FOR PRESIDENT, HE CREATES JOBS'. The balloon was inflated and launched in Denver, Arapahoe County, Colorado in mid-October, 2012, and was retrieved, de-flated and placed in storage on November 7, 2012. The organization has had no further operational activity subsequent to November 7, 2012, and desires to dissolve.

The organizers of the nonprofit organization were and are "senior citizen, grass-roots" taxpayers with no affiliation with any political party or political movement. The organization has no resources with which to hire any consultants such as attorneys, accountants, bookkeepers, or political experts. Therefore, our Treasurer, with the help of members of our committee has prepared the FEC Form 3X Final Report. We hope this is sufficient information for your commission. Thank you.





