
On behalf of K&L Gates LLP, we forgive the Gilmore for President LLC from paying outstanding balances due from legal services provided in 2015.



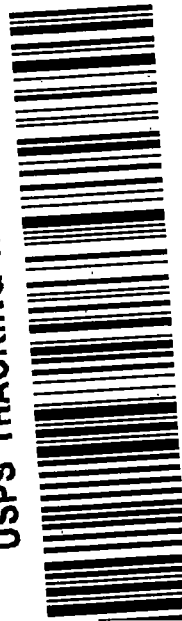
