To Whom It May Concern:

Donald M. Payne Jr. for Congress would like to thank you for your interest in making a contribution to Donald M. Payne Jr.'s 2016 campaign for the United States House of Representatives. The purpose of this letter is to inform potential contributors of federal campaign finance laws that apply to non-federal political committees.

A political committee that is not registered with the Federal Election Commission (FEC) can contribute to federal committees provided it is able to certify that it has sufficient federally permissible funds in its account at the time it is making a contribution(s) to a federal committee(s). Federally permissible sources refer to contributions from individuals and political committees registered with the FEC.

A non-federal political committee can give up to \$1,000 in the aggregate to all federal committees over the course of a calendar year without having to register with the FEC.

A non-federal political committee that chooses to give in excess of \$1000 to federal committees must register with the FEC by filing a Form 1 (Statement of Organization) within 10 days of making an expenditure (i.e., contribution) in connection with a federal election that causes it to exceed the \$1000 threshold. In addition to registering, the committee must report its expenditure(s) to the FEC on a Form 3X (Report of Receipts and Disbursements). The committee must file Form 3Xs with the FEC on a quarterly basis until the committee terminates its federal activities, which can be requested with an initial filing.

Don Payne for Congress requires the following in order to accept a contribution from a non-federal political committee into its federal account:

- certification that the committee has sufficient federally permissible funds in its account(s);
- certification that the committee has registered/will register with the FEC if the committee's contribution to the Donald M.
   Payne Jr. for Congress exceeds \$1,000;
- certification that the committee will file the requisite Form 3X disclosing the committee's contribution to Donald M. Payne,
   Jr. for Congress if the contribution exceeds \$1,000.
