Dear Mr. Reilly:

This letter is prompted by the Commission's preliminary review of the report(s) referenced above. The review raised questions concerning certain information contained in the report(s). An itemization follows:

-Your report discloses "Unitemized Cash Receipts" totaling \$125,770.59 on Schedule A for Line 11(a)(i). The Commission requires a committee to itemize contributions from individuals with an aggregate year-to-date total exceeding \$200. Since these cash receipts do not appear to meet this threshold, you should not itemize them on Schedule A supporting Line 11(a)(i). Instead, the total of these receipts should be added to the total of unitemized receipts on Line 11(a)(ii) of your Detailed Summary Page.

Any amendment or clarification should be filed with the Federal Election Commission. Electronic filers must file amendments in an electronic format and must submit an amended report in its entirety, rather than just those portions of the report that are being amended.
