This letter is to inform you that as of February 27, 2002 the Commission has not received your response to our request for additional information, dated February 6, 2002. This notice requests information essential to full public disclosure of your federal election campaign finances. To ensure compliance with the provisions of the Federal Election Campaign Act (the Act), please respond to this request (copy enclosed).

An adequate response must be received at the Commission by March 20, 2002. Adequate responses received on or before this date will be taken into consideration in determining whether audit action will be initiated. **Requests for extensions of time in which to respond will not be considered.** Failure to provide an adequate response by this date may result in an audit of the committee. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action.

Electronic filers must file amendments in an electronic format and must submit an amended report in its entirety, rather than just those portions of the report that are being amended. Dear Mr. Richardson:

This letter is prompted by the Commission's preliminary review of the report(s) referenced above. The review raised questions concerning certain information contained in the report(s). An itemization follows:

-A review of the reports filed by your committee (pertinent portion(s) attached) indicates that your committee received one or more transfers from the Arizona Republican Party, the Colorado Republican Party, the Montana Repub. State Cen. Comm., the Republican Party of Hawaii, and the Washington State Repub. Party which has not been disclosed on their report(s) of receipts and disbursements. Please provide clarifying information regarding the source of the transfer(s) received by your committee.

-On Schedule H1 of your report, you have used an incorrect method of allocation of shared administrative expenses and voter drive costs. State party committees are required to allocate these expenditures according to the ballot composition ratio. 11 CFR §106.5(d). Please amend your report to clarify the incorrect method of allocation as well as the inclusion of additional Schedule H1's using the fixed federal percentage ratio for national party committees.

-Schedule H3 of your report discloses "Oregon 570 Liberty SE #200" as the name of the account for transfers received from your non-federal account for shared activity. Please verify that these transfers were in fact received from your committee's non-federal account and amend your report with clarifying information.

-On Schedule H4 supporting Line 21(a) of the Detailed Summary Page, you have failed to include the total EVENT YEAR-TO-DATE amount for Administrative/Voter Drive payment(s). Please amend your report to include the missing EVENT YEAR-TO-DATE total(s).

-Itemized disbursements must include a brief statement or description of why the disbursements were made. Please amend Schedule(s) H4 of your report to clarify the following description(s): "expenses for DC trip", "reim. for nonfundraising event", "reim. supplies", and "general consulting". For further guidance regarding acceptable purposes of disbursements, please refer to 11 CFR §104.3(b)(3).

-On Schedule D of your previous report, you disclosed a debt owed to your committee from Darryl Howard and Sandy Howard. This obligation, however, has been omitted from this report. Please amend your report to include this debt on Schedule D supporting Line 9 of the Summary Page. All debts and obligations must be disclosed until extinguished. 11 CFR §104.11

-Schedule A supporting Line 11(a)(i) discloses anonymous contributions received from several contributors totaling \$140.00, \$100.00, and \$119.25. Please be advised that an anonymous contribution is limited to \$50. Any amount in excess of \$50 may not be used for federal election purposes. 11 CFR §110.4(c)(3)

A response or amendment to your original report(s) correcting the above problem(s) should be filed with the Federal Election Commission within fifteen (15) days of the date of this letter. Electronic filers must file amendments in an electronic format and must submit an amended report in its entirety, rather than just those portions of the report that are being amended.
