
Dear Mr. Noble:

On March 16, 1994, the American Nuclear Energy Council (ANEC), a 501(c)(6) trade association, merged with other Washington-based nuclear industry associations to form the Nuclear Energy Institute (NEI). ANEC was the connected organization to a separate segregated fund (the American Nuclear Energy Council Federal Political Action Committee, FEC Identification Number C00239848) from December, 1989 until the effective date of the merger, March 16, 1994. The other constituent corporations to the merger, both 501(c)(6) associations, (the Nuclear Utility Management and Resources Council (NUMARC) and the U.S. Council for Energy Awareness (USCEA)) were not previously connected with any such fund.

In conversations with attorneys in your office prior to the merger, I indicated that it was the intent of NEI to become the connected organization to the fund. It is my understanding, based on those same conversations, that all that is necessary to complete this transaction is to file an amended Statement of Organization with the Federal Election Commission. Enclosed is the amended Statement.
