
This letter is in response to your recent request for additional information or clarification. There was a question of PATPAC's contribution to two separate committees and whether the contribution was excessive for the election cycle.

Regarding the contribution for DeWine for US Senate, made on 4/6/2006 in the amount of \$5,000 to the Primary election, this contribution was not excessive. However, we did make an error in reporting a previous contribution on 6/6/2005 of \$1,000 to DeWine for Senate that was actually given to DeWine for Congress, a separate committee. PATPAC has amended its July 2005 Monthly report to reflect this. In addition, attached is a copy of the original check for your review.

Regarding the contribution for Pat Roberts for Senate, made on 4/7/2006 in the amount of \$5,000, this contribution is excessive. We did not designate this contribution to the General08 election and we have requested a refund from the Pat Roberts for Senate committee. Attached is a copy of this request for your review.
