This submission is in response to the Commission's request for additional information letter dated 3/12/2017. This letter was in regards to the Bonnie Watson Coleman for Congress 48 hour report dated 10/20/2017, as well as the 48 hour report dated 11/4/2017.

- 1) The 48 hour report, originally due on 10/22/2016 covering the 48 hour contributions received on 10/20/2016, was not filed due to technical error. Using the e-filing online system, the Committee had believed the 48 hour report was transmitted to the FEC successfully. However, upon later review, it was discovered the report was not actually received by the FEC. The Committee was not made aware of this issue until after the 48 hour reporting period had closed, thus the 10/20/2016 report was never amended to reflect the \$2,500 contribution from Bayada US PAC. In addition to the online filing of this response, the Committee will be mailing a copy to the FEC with an attachment showing a screenshot of the NGP software used to transmit this 48 hour report. The screenshot shows this report as being e-filed on 10/21/2016 at 6:19pm.
- 2) The 48 hour report, originally due on 11/6/2016 covering the 48-hour contributions received on 11/4/2016, did not include the \$1,000 contribution from Friends of Shirley Turner. While this contribution was reported on the 30 day Post-General report, we were not notified of this contribution until after the 48-hour reporting period has closed. Therefore, it was not adequately disclosed at the time of 48-hour reporting.

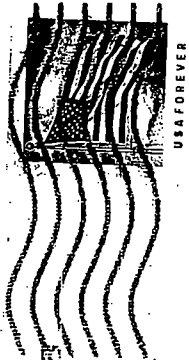

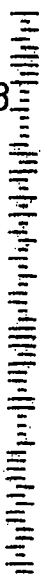
