Dear Mr. Krebs:

This letter is in response to the questions you raised concerning the above referenced report. An itemization follows:

1. Line 11(a)(ii) of the Detailed Summary Page discloses \$74,658.89 in unitemized receipts from individuals/persons other than political committees during the reporting period. This figure does not include any receipts from a single source that aggregate greater than \$200.00 in the calendar year.
2. Schedule B supporting Line 23 of the above report discloses contributions to the National Police Defense, New Economy Political Committee, Rainforest Alliance, and Tenders Inc. which are non-federal committees, therefore the report was amended to disclose these donations on Line 29 of the Detailed Summary Page.
3. Bank fees were erroneously reported on Line 29 of the Detailed Summary Page, the report was amended to move these bank fees to Line 21(b), "Other Federal Operating Expenditures" of the Detailed Summary Page.

In addition to this letter I have submitted an amended report in its entirety to the Federal Election Commission in electronic format. I hope that this letter has been helpful and if you require any additional information, please feel free to contact me.
