- 1. The cover letter attached to your report describes disbursement(s) related to an apparent unauthorized disbursement of Committee funds. Although the Commission may take further legal action regarding this apparent improper use of Committee funds, any further clarifying information that you can provide will be taken into consideration. (11 CFR §102.9, 102.15, and 104.3)
- 2. Your report includes a cover letter and bank statements regarding misappropriation of Committee funds. Each report submitted by a political committee under 11 CFR §104 must be completely disclosed on the appropriate FEC form. Please re-submit your report on FEC Form 3X to include the information disclosed on the cover letter and bank statements. (11 CFR § 104.2(e)) FEC Form 3X can be downloaded from the FEC website at http://www.fec.gov, or requested through the FEC Faxline at (202) 501-3413.

Please note, you will not receive an additional notice from the Commission on this matter. Adequate responses must be received by the Commission on or before the due date noted above to be taken into consideration in determining whether audit action will be initiated. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action. Requests for extensions of time in which to respond will not be considered.
