Re: National Restaurant Association PAC Amended Reports

Dear Sirs:

The National Restaurant Association PAC ("NRA PAC" or "Committee") recently retained an outside accounting firm specializing in political action committees to conduct an audit of its PAC records in order to resolve a discrepancy between the cash on hand reported on the FEC reports and the cash on hand in the bank. The enclosed amended reports for October, 1997 through December, 2001 reflect the results of that audit.

After initially reviewing three years of financial records, the auditors could not identify the cause of the discrepancy. Therefore, NRA PAC asked the auditors to continue the audit back to September 1997 at which point the discrepancies were explained. The Committee discovered that a former employee, who had been responsible for the NRA PAC's bookkeeping and reporting, had misappropriated funds from the Committee. Thus, the attached amended reports show a debt owed to the Committee from the former employee starting in 1997 to the present. The Committee has requested a full refund from the former employee and will report the debt, consistent with prior Advisory Opinions issued by the Federal Election Commission, until such time as the reimbursement has been received. See e.g. Advisory Opinion 1991-38.

There are also several additional amendments to the reports prompted by the poor recordkeeping and reporting of prior staff members. For example, after examining the complete bank records, the Committee auditors discovered purported receipts that were itemized on the FEC reports, but for which there was no corresponding contribution record. Inversely, the Committee discovered contributions that were deposited but not reported. Moreover, the Committee discovered and refunded apparently improper contributions that had previously been misreported.

Thus, the Committee is making comprehensive amendments to its reports to account for these and other reporting issues, such as voided contributions. The cash on hand shown on the Committee's 2001 year end report is consistent with the Committee's actual cash on hand in the bank after conducting a bank reconciliation.

Finally, please be advised that the Committee has taken steps, such as conducting monthly bank reconciliations, to insure that these problems do not reoccur.
