This letter is in response to your letter of January 27, 2005 regarding the October Quarterly Westmoreland for Congress FEC report. I have addressed each of your inquiries separately below:

1) Attached please find information for Schedule A pages in which possible excessive contributions were in question. In actuality, none of the individual contributions are excessive. For Form 3 reports, our software does not pull from the fields that distinguish these individuals like prefix, and suffix. Because of this limitation, it appears that some of these donors are the same people when none are. One in question was a matter of father and son. Another in question is the result of a husband and wife name. Others had the wrong cycle next to them, but the correct cycle in the database. Please note the correct cycle listed on the attachment

With regard to the excessive contributions from candidate committees; Linder for Congress contributions are not excessive. The \$1000 contribution made on 09/24/2004 was initially designated to the General election cycle, because this committee had already contributed to the General election cycle we sent a letter and got confirmation to redesignate the contribution to the Run-Off Election cycle. This transaction is properly documented in the database. However, Congressman Nathan Deal's campaign committee and Friends of Bobby Jindal campaign committee do have excessive contributions. We were under the impression that the contribution limit for candidate committees had increased along with the limit for individuals. We realize now that this limit was unaffected by BCRA. For this reason, we have refunded their contributions and are mailing a photo copy of these checks via USPS.
