This letter is written on behalf of the Plasterers' and
Cement Masons' Political Action Committee in response to your
letters of June 15, 1994 and July 7, 1994 regarding the above-
referenced reports. Initially, I would like to note that your June
15 letter has not been located anywhere in our client's files and
to the best of our client's knowledge it was never received.

Your July 7 letter, with a copy of the June 15, 1994
letter, was received. In response to that letter our client has
prepared amended reports and enclosed them with this letter.


The amendments identify the amounts previously reported
as received from the "Cement Masons COPE" as unitemized
contributions received from members. Cement Masons COPE was
actually the collecting agent but was inadvertently listed on the
initial reports as the contributor.

The collecting agent collects monies from members of the
connected organization and remits the contributions to the political
action committee. Our client has verified that monies are collected
from a voluntary checkoff of five cents per hour and that none of
the members have contributed more than \$200. Accordingly, the
amounts remitted are identified as unitemized contributions on the
amended reports.
