The National Football League ('NFL') provided .5 hours of professional staff time (valued at approximately \$148.54) in this reporting period with respect to PAC activities such as fundraising and decision making about contributions. The National Football League also provided 10.0 hours of administrative staff time (valued at approximately \$220.00) in this reporting period with respect to PAC activities such as fundraising and decision making about contributions. All of the services, with respect to PAC activities such as fundraising and decision making about contributions, that the NFL donated to the PAC for the period of October 1, 2018 through October 17, 2018 took place on October 03, 2018 through October 17, 2018. In addition, the NFL provided 10.25 hours of professional staff time (valued at approximately \$1575.94) with respect to website development activities related to the PAC. On July 31, 2018, Gridiron-PAC made a \$3,500 in-kind services prepayment to the NFL. The total funds retained by the NFL on prior prepayments, as of September 30, 2018, was \$2072.89. In this reporting period, the prepayments are used to offset \$1944.48. The total funds retained by NFL as of October 17, 2018 is \$128.41.
