The Georgia Bankers Association PAC is filing this Schedule F3XA form 3X in response to the notice from Campaign Finance Analyst, Maureen Benitz dated 4/9/2003. A disbursement dated 3/12/2002 to 'Denise Najette for Congress' should have been designated For 2002 Primary Debt Retirement. Originally, the disbursement was properly classified to the 2002 Primary, but it was not specified for debt retirement. The same error took place with a 3/12/2002 disbursement to 'David Scott for Congress' in the amount of \$500. Originally, this 2002 Primary disbursement was not specified for debt retirement. Both disbursements have been specified for debt retirement on this amended filing. Another problem took place with a 3/12/2002 disbursement to 'David Scott for Congress' in the amount of \$5,000 that was designated for the 2002 General Election. In making this disbursement, The Georgia Bankers Association PAC failed to take into account a 3/4/2002 \$2,500 contribution to the same candidate from an affiliated PAC, the ABA BankPAC, that had also been designated for the 2002 General Election. The two contributions together total \$7,500 and exceed the limit for the election. Therefore, we have written a letter to the candidate, dated 4/24/03, requesting a refund of the \$2,500 excess. This refund will be shown on our 2003 Mid-Year Report.
