This letter is prompted by the Commission's preliminary review of the report referenced above. This notice requests information essential to full public disclosure of your federal election campaign finances. **Failure to adequately respond by the response date noted above could result in an audit or enforcement action.** Additional information is needed for the following 1 item(s):

- Schedule H3 discloses the receipt of funds from your connected organization totaling \$9,045.67. The Act prohibits the receipt of funds from national banks, corporations, and labor organizations. However, a separate segregated fund may be reimbursed for any solicitation or other administrative expense provided that the reimbursement is made no later than thirty days after the expense was paid by the separate segregated fund. (52 U.S.C. §30118 (formerly 2 U.S.C. §441b) and 11 CFR §114.5(b)(3))

The Commission notes the refund of the prohibited contribution(s) disclosed on your July Quarterly Report (4/1/14 - 6/30/14). Although the Commission may take further legal action concerning this matter, your prompt action in refunding the contribution(s) will be taken into consideration.

**Please note, you will not receive an additional notice from the Commission on this matter.** Adequate responses must be received by the Commission on or before the due date noted above to be taken into consideration in determining whether audit action will be initiated. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action. **Requests for extensions of time in which to respond will**
