RE: Amended 1998 30 Day Post-General Report

1. "Schedule A discloses contributions from organizations that are not a political committee registered with the Commission. In order for your committee to accept contributions from unregistered organizations into accounts used to influence federal elections, your committee should take steps to insure that the contributors used permissible funds to make the contributions."

The committees listed on line number 11c, Minore Campaign Committee, 3rd District Democratic Club, Citizens for John Cherry, & Friends of Debbie Cherry, are all state registered Candidate or Independent Committees and all used permissible funds. The state of Michigan prohibits accepting contributions from a corporation, labor organization, government contractors, persons holding a casino interest, or an anonymous contribution.

2. "Schedule A of your report discloses transfers from the 9th District Democratic Committee, however these transfers were not disclosed on their report of receipts and disbursements."


The receipt from 9th District Democratic Committee (C00158022) was from their federal account and reported. See F.E.C. IMAGE 98033942524 (Page 24 of 25) item A and F.E.C. IMAGE 98033774897 (Page 16 of 18) item D.

3. "Schedule A further disclosed a transfer from the Michigan Democratic Party State Acct II. The Michigan Democratic Party State Acct II appears to be a non-federal account."

The Michigan Democratic Party State Account II is not a federal account. The Genesee County Democratic Party has one account and was not aware that it could not receive funds that would not be used for federal election purposes. The funds will be returned to the donor, and replaced with funds from a federal account.

The address for the Democratic party of the 8th-Congressional District was incorrect, & the 9th District Democratic Committee should have had two entries for the \$6,000 receipt, one for \$2,000 and one for \$4,000. Please note the amended page.
