Please note: on 8/25/2023, the Committee discovered an unauthorized expense in the amount of \$9900 clearing its bank account. Because the Committee regularly reviews and reconciles bank activity, this item was discovered the same day it was presented to the account. The Committee immediately reached out to the bank to file a fraud claim and close the bank account, and additionally filed a police report. It is believed that a check was taken from the USPS and recreated and cashed to an unauthorized entity. The Committee does not have an internal bad actor, the situation was managed immediately and all proper steps taken. The Committee takes the Act very seriously, and as soon as the funds are returned to the Committee from the bank fraud department, we will report the funds as an Other/Miscellaneous Income - Return of Unauthorized Funds.
