On March 7, 2001, you were notified that a review of the above-referenced report(s) raised questions as to specific contributions and/or expenditures, and the reporting of certain information required by the Federal Election Campaign Act.

Your March 19, 2001 response is incomplete because you have not provided all the requested information. For this response to be considered adequate, the following information is still required.


-A review of reports filed by your committee (pertinent portion attached) still indicates that your committee received transfers from the DNC Services Corporation/Democratic National Committee which have not been disclosed on their report(s) of receipts and disbursements. Your response states that "an apparent clerical error, however, resulted in these transfers being reported as transfers to the Tennessee Democratic Party on the DNC's October 2000 Quarterly Report". You also state that you have contacted the DNC in order to correct this discrepancy. Please be advised that you should clarify that the transfer was from the federal account of the DNC and intended as a contribution to the federal account of your committee.

An adequate response must be received at the Commission by April 18, 2001. Adequate responses received on or before this date will be taken into consideration in determining whether audit action will be initiated. **Requests for extensions of time in which to respond will not be considered.** Failure to provide an adequate response by this date may result in an audit of the committee. Failure to comply with the provisions of

the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action.
