
To the Senate Office of Public Records:

Procedures for Requesting and Reporting Contributor Information

1. All solicitations must include a clear and concise statement regarding the information required to be reported in accordance with public law including name, mailing address, occupation, and employer for each individual whose contributions aggregate in excess of \$200 in a reporting cycle. (Solicitations must also include a statement regarding the campaign contributions limits, and prohibited contributions from corporations, foreign nationals and federal government contractors).
2. When mail is opened daily, a copy of the contributor's check or credit card remittance and the contributor information sheet is copied and attached with the copy of the deposit slip/credit card batch report and placed in a deposit folder
3. The deposit folder is reviewed and the contribution and contributor information is entered into the FEC reporting database daily.
4. If the contributor information is not received when a contribution is received, the contributor information in the FEC report database is reviewed to determine whether the contributor has made a previous contribution to the campaign.
5. All contributors with missing information are mailed letters, which request the information needed. The letter cannot contain a request for solicitation. The letter must inform the contributor of the information that is missing and required by law, including name, address, occupation and employer. (See form letter attached). A pre-addressed return envelope is included with the letter. **When contribution information is missing, a letter must be mailed to the contributor in less than 30 days of receipt of the contribution.**
6. As missing contributor information is received, it is entered at the time of receipt, into the FEC report database and reported as a memo item on the next report filed with the FEC.
