This letter responds to your letter dated March 19, 1997, in which you asked questions about the October Monthly Report (9/1/96 - 9/30/96) filed by the Philip Morris Companies Inc. Political Action Committee ("PHIL-PAC"). Responses to your questions are provided below. A copy of the relevant pages of the Monthly Report, as corrected, is enclosed.

Item #1: Line 23 of the Detailed Summary Page does not equal the sum of the entries itemized on Schedule B.

Response: A corrected Schedule B for Line 23 is attached. The new total of \$110,600 is the same as that appearing on the Detailed Summary Page.

Item # 2: Schedule A discloses a total of \$202.00 received from Philip Morris Management Corp. ("PMMC"), the connected organization.

Response: The funds received from PPMC were to reimburse PHIL-PAC for administrative expenses.

PHIL-PAC incurred an administrative expense in the amount of \$175 for new bank checks. It paid for this expense through an automatic debit to its bank account. The debit appeared on PHIL-PAC's bank statement dated August 1, and PPMC reimbursed PHIL-PAC for the new-check charge on August 12, less than 30 days later. The reimbursement by PPMC appeared on the bank statement that PHIL-PAC received on September 4, 1996.

PHIL-PAC incurred a separate administrative expense in the amount of \$27, which was also reimbursed by PMMC. PHIL-PAC is refunding this amount to PMMC. A copy of the check from PHIL-PAC to PMMC in the amount of \$27 is attached.


Item #3: Payment by PHIL-PAC on 9/17/96 of \$660.00 to PMMC for "in-kind contribution Representative Herbert Bateman (R-VA-1)," as reported on Schedule B

Response: PHIL-PAC made this payment to PMMC to cover the cost of certain promotional items that PHIL-PAC purchased from PMMC for use in connection with a fundraising event for Rep. Bateman. The fundraising event occurred on October 6, 1996.

PMMC did not make any contribution, in-kind or otherwise, to Rep. Bateman or to any other candidate for federal office or political committee supporting a candidate for federal office. The term "in-kind contribution" as it appears in the Report refers solely to the contribution from PHIL-PAC to Rep. Bateman.
